- 2. Attendances at classes in law courses is compulsory. Failure to attend 70% of the classes in a law course, without prior satisfactory explanation to the course convenors, may lead to findings of failure to follow instruction and unsatisfactory performance. This may entail disallowing you from sitting an examination or completing graded assignments, or result in the Faculty late-dropping a course on the basis of your failure to follow instruction as required in the course. In serious cases, failure to follow instruction or unsatisfactory performance may also lead to a recommendation that you discontinue your JD studies.
- 3. There will be no class on public holidays and on the following dates, unless otherwise instructed by the course convenors:
 - i. Reading week: October 13 18, 2025 (1st semester) and March 9 14, 2026 (2nd semester).
 - ii. Teaching suspension period for Lunar New Year: February 17 23, 2026.
 - iii. University holidays: December 24, 2025 (full day), December 31, 2025 (after 1:00 pm), February 16, 2026 (after 1:00 pm), and March 16, 2026 (full day).

4. In the second year of JD study:

- i. The normal annual study load is 78 credits of JD core courses and elective courses taken in the second year of JD study.
- ii. Candidates will be enrolled in the core courses by default for both regular semesters.
- iii. To proceed to the PCLL programme, candidates will need to devote 12 elective credits to PCLL prerequisites, which are JDOC3015 Company law, and JDOC3102 Evidence.
- iv. The JDOC1011 Dissertation course is a full-year course. Enrolment and the study load will be counted as the summer semester course on the academic transcript. Assessment result will only be released in early September. Failure in JDOC1011 Dissertation course at first attempt will defer your graduation and affect your study plan (i.e., admission to the PCLL programme).
- v. Prior approval from the Programme Director is required if your study plan deviates from the JD syllabus. Please write to idstu@hku.hk with your personal particulars (e.g., Chan Tai Man John, 3035123456, JD1), your study plan, justification with supporting documents, as soon as possible but no later than the end of the add-drop period of the respective semester, for consideration.
- 5. Courses offered in the January and June semesters are intensive courses. Enrolments and study loads will be counted as 2nd semester and summer semester courses, respectively, on the academic transcript. Timetables are subject to change and/or cancellation without prior notice due to unforeseen circumstances or low enrolment. Availabilities are normally confirmed around December and May, respectively, of the academic year. Candidates are reminded to accept any associated risks. Assessment results will only be released in mid-June and early September, respectively.

Candidates who wish to enrol a course in June semester should not exceed the study load of 72 credits in the regular semesters. Failure in a June semester course at first attempt will defer your graduation and affect your study plan (i.e., admission to the PCLL programme).

- 6. Absence from the final assessment and/or failure in a course will be subject to the provisions of regulations JD4, JD5, JD10, JD11, and JD12, as set forth in the respective intake regulations.
- 7. Candidates are required to pay the standard composition fees beyond the normative study period, to satisfy the graduation requirements.
