JD Timetable (Year One), AY2026-2027

1. The timetable and venue are subject to change at the discretion of the course convenor(s). Please refer to the [Examinations Office](#) for the location of classrooms, the [Campus Map](#) for location of buildings, and check the news announcement section on the course Moodle regularly for any updates.
2. **Attendances** at classes in law courses is **compulsory**. Failure to attend 70% of the classes in a law course, without prior satisfactory explanation to the course convenors, may lead to findings of failure to follow instruction and unsatisfactory performance. This may entail disallowing you from sitting an examination or completing graded assignments, or result in the Faculty late-dropping a course on the basis of your failure to follow instruction as required in the course. In serious cases, failure to follow instruction or unsatisfactory performance may also lead to a recommendation that you discontinue your JD studies.
3. There will be no class on public holidays and on the following dates, unless otherwise instructed by the course convenors:
 - i. Reading week: October 12 – 17, 2026 (1st semester) and March 8 – 13, 2027 (2nd semester).
 - ii. Teaching suspension period for Lunar New Year: February 6 – 12, 2027.
 - iii. University holidays: December 24, 2026 (full day), December 31, 2026 (after 1:00 pm), February 5, 2027 (after 1:00 pm), and March 16, 2027 (full day).
4. **In the first year of JD study:**
 - i. The normal annual study load is 66 credits of JD core courses and elective courses taken in the regular semesters (excluding the summer semester).
 - ii. Candidates will be enrolled in the core courses by default for both regular semesters.
 - iii. Candidates are recommended to enrol in one (1) elective course in first year of study. It is recommended that this elective be taken in the 2nd semester, preferably one that fulfils the Chinese Law requirement, if applicable.
 - iv. Prior approval from the Programme Director is required if a candidate intends to enrol a course in the June semester of their first year of study. Please write to jdstu@hku.hk with your personal particulars (e.g., Chan Tai Man John, 3035123456, JD1), your study plan, justification with supporting documents, and your choice of a June semester course, by April 30, 2027, for consideration. If approved, credits earned in the June semester will count towards the total study load for the candidate's first year of study. The candidate will take 72 credits of JD courses in each of their first and second years of study.
 - v. Enrolment in **only one (1) course in the June semester** is permitted, provided that prior approval of an overload request has been granted by the Programme Director. The enrolment and study load will be counted as a summer semester course on the academic transcript. Assessment result of the June semester course will only be released in the following academic year (i.e., early September).
5. Courses offered in the January and June semesters are intensive courses. Enrolments and study loads will be counted as 2nd semester and summer semester courses, respectively, on the academic transcript. Timetables are subject to change and/or cancellation without prior notice due to unforeseen circumstances or low enrolment. Availabilities are normally confirmed around December and May, respectively, of the academic year. Candidates are reminded to accept any associated risks. Assessment results will only be released in mid-June and early September, respectively.

6. Absence from the final assessment and/or failure in a course will be subject to the provisions of regulations JD4, JD5, JD10, JD11, and JD12, as set forth in the respective intake regulations.
7. Candidates are required to pay the standard composition fees beyond the normative study period, to satisfy the graduation requirements.
